Uncas is rural community 24 km east of Sherwood Park with a catchment area that includes acreages and small lake communities within it including Collingwood Cove, Antler Lake and North Cooking Lake. The demographics show a large variance in socio-economic conditions.

There are currently 169 students registered for the 2024-2025 school year. This is a drop from the previous school year of 21students.

There are 8 classroom teachers, 4 educational assistants and 1 part time library technician.

We have joined the EIPS-Mental Health flagship Group working with Mardi Hardt. This group emphasizes restorative practices and continuing to build a school community.

- This year we are fortunate to continue our work with the Mental Health Capacity building program sponsored by the County of Strathcona. Mental Health Capacity Building lead Bree Grundy works with students and staff promoting positive mental health and strengthens social-emotional skills in children, youth and families through awareness, knowledge and skill building.
- A firm, consistent expectation of positive citizenship and kindness will continue to be an area of focus. Outcomes of disciplinary actions are focused on correction of behaviour over, but not exclusive to punitive consequences.
- There will be continued emphasis on bullying and citizenship. Counsellor Dianna Graziano will lead Bully Awareness Week 2024, in late November. Mr. Kennerd will again request Parent Advisory purchase sessions from Saffron in Sherwood Park to address bullying and Internet Safety.
